Dr. James B. Lynch was a professor of art history at the University of Maryland. After his retirement, he spent several years researching the history of the Custis family in Europe and America. He authored a two-volume work on the family: *The Custis Chronicles: The Years of Migration* (published 1993) and *The Custis Chronicles: The Virginia Generations* (published 1997).

Content Description

The collection consists of the research materials used by Dr. Lynch in writing *The Custis Chronicles*. Materials include correspondence; copies of wills, inventories and other documents; and articles and other publications about the Custis family.
