Princess Anne County was named for Anne, daughter of King James II, who became queen of England in 1702. The county was formed from Lower Norfolk County in 1691 and became extinct on 1 January 1963, after its consolidation with the city of Virginia Beach. The county seat was Princess Anne.

Scope and Content

Princess Anne County (Va.) Judgments, 1750-1913, contain civil cases heard in County Court, Superior Court of Law, Circuit Superior Court, and Circuit Court in which justice was administered on the strictly formulated rules of common law. The majority of cases in this record series relate to matters of debt.
