King George County Fair Association was organized in King George, Virginia, on April 11, 1925. It was responsible for planning and organizing the annual King George County Fair.

The record books were used as exhibits in an unidentified court case heard in King George County Circuit Court.

King George County Fair Association Record books, 1925-1951, record the meetings of the organization's stockholders from its inception in 1925. Information found in the record books includes date and time of meetings, election of officers, list of stockholders, officer reports, financial transactions, and decisions made by stockholders related to activities involving the King George County Fair.
