Historical Information

Lunenburg County was named for George II, duke of Brunswick-Luneburg, a German possession of the Hanoverian kings of England. It was formed from Brunswick County in 1745.

Scope and Content

Lunenburg County (Va.) Clerk's Fee Book, 1887-1889, documents charges for docketing common law and chancery cases, recording documents such as deeds and wills, and other fees collected by the clerk of the court. There is an alphabetical index by surname at the beginning of the volume.
