Historical Information

Context for Record Type: Business records, volumes and loose records, are in some cases transferred to the Library of Virginia as components of court record transfers. This business record in some cases were stored in the local court building for safekeeping by business owners. In other cases, business records (particularly account books, ledgers, etc.) may have been filed in a court case as an exhibit. This business record exhibit appeared both in chancery causes, this record serving as exhibits for business dissolution cases, debt suits, and contract disputes.

Locality History: Prince Edward County was named in honor of Edward Augustus, a son of Prince Frederick Louis, a grandson of George II, and a younger brother of George III. The county was formed from Amelia County in 1753. Its area is 357 square miles, and the county seat is Farmville.

Scope and Content

Prince Edward County (Va.) Business Record, 1859-1866, is comprised of a record created by individuals in pursuit of documenting business activities in and around Prince Edward County (Va.). Represented records largely consists of an account book.

Scope and Content

Historical Information: Brightwell and Davis was a partnership composed of Josiah W. Brightwell and E.P. Davis. They operated a flour mill from 1859 to 1865 in the town of Farmville located in Prince Edward County, Virginia.

Scope and Content: Brightwell and Davis Journal, 1859-1866, records the accounts of individual customers. Each account lists transactions in chronological order. Information found in each entry include date of transaction, service rendered, quantity purchased, cost per bushel, barrel, or pound, amount owed, form of payment, and amount paid. Journal includes an index listing customers' names in alphabetical order and the page number their accounts can be found. Payments made by cash, credit, and barter of items such as barrels.
