Historical Information

Scott County was formed from Lee, Russell and Washington counties by a statute adopted on 24 November 1814. The county court first met on 14 February 1815. Scott County was named for General Winfield Scott, a native of Virginia, in recognition of his victories during the War of 1812. General Scott was later commanding general of the American army during the war with Mexico.

Scope and Content

Scott County (Va.) Wills and Settlements of Estates cover the years 1845-1852. Box 66 contains the surnames A-L and Box 65 contains the surnames M-Z.
