In 1987 The Board for Professional Soil Scientists was created to certify professional soil scientist for the "preservation of health, safety and welfare of the citizens of Virginia". The code of Virginia in 2004 reflects the inclusion and addition of Wetland Professionals in the regulatory requirements for Professional Soil Scientists. In 2012, the Board was merged with the Board for Geologists to create the Board for Professional Soil Scientists, Wetland Professionals, and Geologists

Scope and Content

Minutes and related attachments documenting the meetings, activities, discussions, policy decisions, and recommendations of the Virginia Board for Professional Soil Scientists, Wetlands Professionals and Geology. Includes official board minutes, as well as draft minutes, committee meeting minutes, agendas and other meeting materials. May also include informal fact finding hearing minutes, correspondence, financial statements, legislation, regulations, reports and resolutions.

Electronic records often contain board meeting packets with various attachments and draft minutes, while paper records often include minutes only. There may be some duplication between paper and electronic records. For transfers prior to 2012, records of individual boards were accessioned separately. After this, transfers of records (records starting in 2008) included all boards, which were accessioned under one accession number.
