Historical Information

Virginia Beach, City of/Princess Anne County (Va.) was in Princess Anne County, which is now extinct. The ocean resort was incorporated as a town in 1906 and as a city by an act of the General Assembly on 14 February 1952. It was greatly enlarged on 1 January 1963 by consolidation with Princess Anne County, which thereby became extinct.

Scope and Content

Virginia Beach, City of/Princess Anne County (Va.) Fiduciary Records, 1710-1953 circa, include miscellaneous records filed in a local court by trustees, administrators, executors, guardians, and committees that related to the performance of their duties managing a person's estate. These records typically include the following; bonds, appraisements, audits, inventories, accounts, estate divisions, settlements, dowery records, etc. Information related to enslaved people are commonly found in these records.
