Biographical Note

John Rigg, who died ca. 1798, appears in the Pennsylvania septennial census for 1786 as a resident of Washington County, Pennsylvania. The estate account in this collection identifies the estate administrator as Gwen Rigg, likely also the wife of John Rigg.

Scope and Content

The John Rigg Estate Account contains the account transactions of Gwen Rigg, acting as administrator of the estate of John Rigg. Included are descriptions of payments and disbursements made by the administrator.
