Biographical Information

Dr. Stephen S. Fuller received a Bachelor's degree in Economics from Rutgers University and a Doctorate in Regional Planning and Economic Development from Cornell University. He has authored hundreds of articles, papers, and reports about the Washington, D.C. area's economic development.

Dr. Fuller joined the George Mason University staff in 1994, serving as Professor of Public Policy. He also served as the Director of the Ph.D. Program of Public Policy from July 1998-2002. Fuller was chosen by the George Mason University Board of Visitors to be a University Professor in September 2001. He also served as a Dwight Schar Faculty Chair. Dr. Fuller is now the Director of The Stephen S. Fuller Institute.

Before joining the George Mason University faculty, Dr. Fuller served on the faculty at George Washington University as Chairman of the Department of Urban Planning and Real Estate Development, as well as spending one year as Director of Doctoral Programs for the School of Business and Public Management.
