Kennedy" (1995); "Evidence Dismissed: The Inside Story of the Police Investigation of O.J. Simpson" (with Tom Lange and Philip Vannatter, 1997); and "A Washington Tragedy: How the Suicide of Vincent Foster Ignited a Political Firestorm" (1998). He recently published his memoir "Confessions of a Guerrilla Writer: Adventures in the Jungles of Crime, Politics and Journalism" (2013).
